**ORDER GRANTING MOTION OF WITHDRAWAL  
AND DISMISSING COMPLAINT**

The above-captioned matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and determination. Having examined its files and records, and being duly advised in the premises, the Commission finds and concludes as follows:

1. On January 3, 2012, Coffeyville Resources Refining & Marketing, LLC (CRRM) filed a formal complaint against Mid-America Pipeline Company, LLC (MAPL) alleging that MAPL knowingly and intentionally violated a Commission Order regarding the classification of interstate and intrastate rates. Complaint of Coffeyville Resources Refining & Marketing, LLC ("CRRM") Against Mid-America Pipeline Company, LLC ("MAPL") for Violation of Orders of the Kansas Corporation Commission ("KCC"), for Charging Rates and Conditions without KCC Approval, and for an Order Requiring MAPL to Comply with KCC Orders, and for Emergency Hearing of Complaint, January 3, 2012 (Complaint).

2. MAPL filed a Motion to Dismiss the Complaint, stating that through a series of correspondence between MAPL and CRRM, CRRM provided to MAPL a more thorough interstate/intrastate breakdown of October 2011 and November 2011 movements, and as a result MAPL submitted a revised invoice to CRRM which CRRM has paid in full. Motion to Dismiss of Mid-America Pipeline Company, LLC, March 23, 2012, paragraph 3 (MAPL Motion, ¶ 3).

MAPL stated because there is no longer an outstanding dispute between the parties, there is no longer a matter for which the Commission can offer a remedy and therefore the matter is moot. MAPL Motion, ¶ 4.

3. In Docket No. 12-MDAP-068-RTS (12-068 Docket), MAPL and CRRM (Joint Parties) filed a Settlement resolving issues in the 12-068 Docket and this instant docket. Notice of Filing of Settlement Agreement, April 3, 2012 (Settlement). In the Settlement, the Joint Parties agreed that within 10 business days of the Settlement, CRRM shall file with the Commission a Motion of Withdrawal of its complaint in this docket. Settlement, ¶ 11.

4. CRRM has filed a motion to withdraw its complaint against MAPL in this matter. Motion of Withdrawal, April 18, 2012.

5. The Commission finds and concludes the subject of this complaint has been resolved between the parties. The Commission grants CRRM's Motion of Withdrawal and dismisses the complaint against MAPL.

**IT IS, THEREFORE, BY THE COMMISSION ORDERED THAT:**


A. The Motion of Withdrawal is granted and the complaint of Coffeyville Resources Refining & Marketing, LLC against Mid-America Pipeline Company, LLC is hereby dismissed.

B. Parties have 15 days, plus three days if service is made by mail, from the date of service of this Order in which to petition the Commission for reconsideration. K.S.A. 66-118b; K.S.A. 2011 Supp. 77-529(a)(1). If no petition for reconsideration is timely filed, this docket shall be closed.
