**SECOND SUPPLEMENT TO APPLICATION FOR DESIGNATION AS AN
ELIGIBLE TELECOMMUNICATIONS CARRIER ON A WIRELESS BASIS**

Telrite Corporation d/b/a Life Wireless. ("Telrite" or the "Company") by and through its undersigned counsel, submits this Second Supplemental Filing to the Kansas Corporation Commission (the "Commission") to provide additional information supporting its request for designation as an eligible telecommunications carrier ("ETC"). The additional information set forth below is incorporated by reference into and further supports the Application filed in this docket on September 5, 2012 and the Supplement to Application filed on January 4, 2013 which included the Company's FCC-approved Compliance Plan.

In connection with the Company's request for ETC designation by the Commission on a combined facilities/resale basis, the Company is requesting designation for purposes of both federal and state universal service funding in the State of Kansas. Contingent on designation for purposes of receipt of both federal universal service funding and state universal service funding state (\$7.77 reimbursement from KUSF) in the State of Kansas, Telrite wishes to supplement its Application to provide for the following Kansas-specific enhancements to Telrite's Lifeline Plan as described in the Application. If

approved by the Commission, the following enhancements will be available only in the State of Kansas at this time. If approved, active lifeline customers of Telrite Corporation d/b/a Life Wireless in the State of Kansas will receive the following enhancements to the generally available Telrite Lifeline Plan:

Special Offer to Kansas Lifeline Customers:

-Three unlimited domestic calling and text days every month will be offered to all Life Wireless customers in the State of Kansas. At the time of enrollment the Kansas customer will be informed of the special offer.

A three-day unlimited talk and text PIN will be provided to the Kansas customer at the time of enrollment and given instructions to redeem at any time before their next monthly anniversary date. It will be explained that on every monthly anniversary date they will receive a text message (SMS) with their three-day unlimited talk and text PIN. The monthly SMS to the customer will instruct them to dial 611 from their handset and follow the simple instructions to redeem the unlimited PIN. They must redeem the PIN before the next monthly anniversary date or the PIN will expire (no rollover).

Marketing and Advertising Enhancements:

- Customer service, retailers, and field reps/distributors will be trained and monitored to ensure the special offer is communicated to all Kansas Life Wireless customers.

- Customers will be informed at time of enrollment/order.

- Signage and handouts explaining the special offer will be required at all Life Wireless events.

- Initial SMS to new customers informing them of offer and monthly reminders to redeem the PIN and special offer.


- Semi-annual postcards to all KS Life Wireless customers promoting the special offer.

CONCLUSION

Telrite provides herein supplemental information supporting its request for designation as an ETC, contingent on designation by the Commission as described above. The Company continues to meet the requirements for ETC designation in the State of Kansas and respectfully requests that the Commission designate Telrite Corporation d/b/a Life Wireless as an ETC for the provision of Lifeline supported service on a wireless basis throughout its Service Area (as defined in its Application) for purposes of federal and state universal service reimbursement.


