## NOTICE OF APPLICATION FOR HORIZONTAL WELLBORE

TO: ALL OIL AND GAS PRODUCERS AND OWNERS OF UNLEASED MINERALS AND WHOMSOEVER CONCERNED:

You, and each of you, are hereby notified that Shelby Resources, LLC, ("Shelby") has filed an application before the State Corporation Commission (the "Commission") requesting an order authorizing the drilling of the Brubaker #1-17H well (the "Well") as a horizontal wellbore. Shelby proposes to drill the Brubaker #1-17H horizontal wellbore upon its Brubaker Unit comprised of the South Half (S/2), the Northwest Quarter (NW/4), and the South Half of the Northeast Quarter (S/2 NE/4) of Section Seventeen (17), Township Twenty-nine (29) South, Range Twelve (12) West of the 6th P.M., Pratt County, Kansas, and the Northeast Quarter (NE/4) of Section Eighteen (18), Township Twenty nine (29) South, Range Twelve (12) West of the 6th P.M., Pratt County, Kansas. The Brubaker #1-17H will be drilled to test the Viola Formation ("Producing Formation"). The proposed surface location, location where the wellbore will first be completed in the producing formation, bottom-hole location, and length of the completion interval of the Brubaker #1-17H are described as follows, to-wit: Surface Location 1,800 feet from the South Line and 249 feet from the East Line of Section Seventeen (17), Township Twenty nine (29) South, Range Twelve (12) West of the 6th P.M., Pratt County, Kansas; First Completion into the producing formation - 2,030 feet from the South Line, and 789 feet from the East Line of Section Seventeen (17), Township Twenty-nine (29) South, Range Twelve (12) West of the 6th P.M., Pratt County, Kansas; Bottom-hole location - 521 feet from the North Line, and 1,798 feet from the East line of Section Eighteen (18), Township Twenty-nine (29) South, Range Twelve (12) West of the 6th P.M., Pratt County, Kansas; Length of the Completion interval - 6,873

The application is pending with the Commission. Any persons who object or protest to such application shall be required to file their objections or protests in writing with the Commission within 15 days from the last date of this publication. If a written protest is not timely filed, the application shall be determined administratively by the Commission and may thereby be granted without hearing or further notice to any interested party. All objections and protests shall clearly state the reasons why granting the application will violate correlative rights, cause waste or pollution. Objections or protests shall be mailed to the Kansas Corporation Commission, Conservation District, 266 N. Main St., Suite 220, Wichita, KS 67202, with a copy to applicant's attorney listed below.
