**JOINT MOTION FOR PROCEDURAL SCHEDULE**

COMES NOW Staff of the Corporation Commission of the State of Kansas (“Staff”) and “Commission” respectively), along with Kansas City Power & Light Company (“KCP&L” or the “Company”), Walmart, Inc. (“Walmart”), Midwest Division – OPRMC, LLC d/b/a Overland Park Regional Medical Center (“OPRMC”), Kansas Gas Service, a division of ONE Gas, Inc. (“KGS”), and the Citizens’ Utility Ratepayer Board (“CURB”)(collectively “Joint Movants”) and respectfully request that the Commission adopt the proposed procedural schedule agreed to by the Joint Movants. In support of their request, the Joint Movants state as follows:

1. On May 1, 2018, KCP&L filed an application seeking permission to make certain changes in its rates for electric service.
2. On May 3, 2018, CURB filed a Petition to Intervene in the above-captioned docket.
3. On May 15, 2018, the Commission granted CURB’s Petition to Intervene.
4. On June 5, 2018, both Walmart and OPRMC filed Petitions to Intervene in the above-captioned docket.
5. On June 13, 2018, KGS filed a Petition to Intervene in the above-captioned docket.
6. The Joint Movants have conferred and have agreed upon the following procedural schedule:

<sup>1</sup> The purpose of the Supplement Direct Testimony is to confirm the accuracy of and support the revenue requirement reductions resulting from the Commission's approval of the Settlement Agreement in Docket No. 18-KCPE-095-MER and the subsequent closing of the GPE-Westar merger, as discussed in the direct testimony in this docket of Mr. Darrin Ives, p. 9, lines 12-15. That Settlement Agreement was approved by the Commission on May 24, 2018, after the filing of the Company's direct case in this docket. The Joint Movants acknowledge that the Supplemental Direct Testimony is not a modification of the initial application that would support a request for the 240-day period to begin again under K.S.A. 66-117(c) or any other statute or regulation.


