RE: Norstar Petroleum Inc. - Application for exception to the 10-year limitation for TA status of the Burson Hutch 3-5, Steckel Farms 1-4 and Steckel Farms 2-4 located in Morton County, Kansas.

TO: All Oil and Gas Producers, Unleased Mineral Interest Owners, Landowners, and all persons whomever concerned.

You, and each of you, are hereby notified that Norstar Petroleum Inc. will file an application to request exception to the 10-year limitation of TA status for the Burson Hutch #3-5 located in the NE SE of Sec. 5, T31S-R41W, the Steckel Farms #1-4 located in the SE SE NW NE of Sec. 4, T31S-R41W, and the Steckel Farms #2-4 located in the NE NE of Sec. 4, T31S-R41W in Morton County, Kansas. The wells in question are part of a secondary recovery unit in the Beauchamp SW field. The Burson Hutch #3-5 has been shut-in since August 17, 2000, the Steckel Farms 1-4 has been shut-in since June 1, 2000, and the Steckel Farms 2-4 has been shut-in since June 1, 2000. All wells will undergo and pass a KCC witnessed mechanical integrity test prior to the applications being filed.

Any persons who object to or protest this application shall be required to file their objections or protests with the Conservation Division of the State Corporation Commission of the State of Kansas within fifteen (15) days from the date of this publication. These protests shall be filed pursuant to Commission regulations and must state specific reasons why the grant of the application would be detrimental to natural resources of the state of Kansas.

All persons interested or concerned shall take notice of the foregoing and shall govern themselves accordingly.

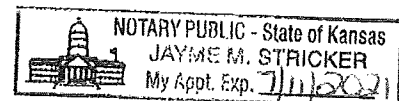
