ORDER ADOPTING AUDIT REPORT AND CLOSING DOCKET

The above-captioned matter comes before the State Corporation Commission of the State of Kansas (“Commission”). Having examined its files and records, and being duly advised in the premises, the Commission finds and concludes as follows:

1. On August 1, 2024, the Commission directed Vantage Point Solutions (VPS) to perform an audit of Southwestern Bell Telephone Company (SWBT) for Kansas Universal Service Fund (KUSF) purposes.

2. On December 18, 2024, VPS filed its Audit Report stating it did not find any KUSF reporting deficiencies during the course of the audit. VPS recommended the Commission issue an Order adopting the Audit Report and close the Docket.

4. The Commission has reviewed the Compliance Report filed by VPS in this matter and finds the recommendations to be reasonable, they should be adopted and this Docket should be closed.

IT IS, THEREFORE, BY THE COMMISSION ORDERED THAT:

A. The Commission accepts and adopts Vantage Point Solutions' Audit Report filed December 18, 2024, and hereby closes this Docket.

B. Any party may file and serve a petition for reconsideration pursuant to the requirements and time limits established by K.S.A. 77-529(a)(1).¹
