**ORDER GRANTING STAFF'S MOTION FOR EXTENSION UNTIL JULY 24, 2025 TO
FILE CAPITAL PLAN RESPONSIVE COMMENTS**

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having reviewed the files and records, the Commission finds the following:

1. On February 6, 2020, the Commission issued its Order Adopting Integrated Resource Plan and Capital Plan Framework (Order) requiring Evergy, Inc. and its operating subsidiaries to make triennial integrated resource plan filings and annual updates, and a process for the Parties to file reports not later than 150 days after Evergy's compliance filings.¹ The Order requires Evergy to file a Capital Investment Plan by February 28th of each year, and give the parties 120 days to submit responsive comments.²

2. On March 26, 2025, Evergy filed its Capital Investment Plan. The Framework allows parties to file responsive comments 120 days after February 28, 2025, which would make the deadline for responsive comments June 27, 2025.

3. On June 27, 2025, Commission Staff (Staff) filed a motion requesting an extension until July 24, 2025 to submit responsive comments to reflect the delayed submission of Evergy's

Capital Investment Plan Update.³ Staff requests that the extension extend to all intervenors, and that Evergy does not object to the extension.⁴

4. K.A.R. 82-1-217(b) allows the Commission to extend any deadline for good cause. Because of the importance of the Capital Investment Plan, the Commission believes allowing the Parties sufficient time to thoroughly analyze the Capital Investment Plan before they file their comments would ensure the comments are informative. Therefore, pursuant to K.A.R. 82-1-217(b), the Commission grants both Staff's Motion for Extension Until July 24, 2025 to File Capital Investment Plan Responsive Comments.

THEREFORE, THE COMMISSION ORDERS:

A. Staff's Motion for Extension Until July 24, 2025 to File Capital Investment Plan Responsive Comments is granted. Staff and Intervenors comments are due July 24, 2025.
