## **APPLICATION**

COMES NOW Western Plains Resources, L.L.C. (Applicant) in support of its Application in the captioned matter and states as follows:

1. Applicant is a L.L.C. authorized to do business in the State of Kansas.

Applicant's address is 2790 N. Anderson Rd., Garden City, KS 67846-9798.

2. Applicant has been issued by the Kansas Corporation Commission Operator's License 35983, which expires on September 3, 2025.

3. Applicant is the owner and operator of the Odd Williams #3 well, 15-093-20757-00-01 (Subject Well), which is located in the Southeast Quarter of the Southwest Quarter of Section 12, Township 21 South, Range 35 West, Kearny County, Kansas. The Subject Well is located on an active oil and gas lease or unit comprising the following lands:

See attachment Exhibit "A"

4. Pursuant to K.A.R. 82-3-111, the well was shut in, or Applicant obtained temporary abandonment status, for the Subject Well on August 6, 2014. The Subject Well has maintained such status from August 6, 2014, to the present date.

5. On or about June 27, 2024, the Kansas Corporation Commission notified Applicant temporary abandonment status for the Subject Well would be denied from and after August 6, 2024, because the Subject Well had been temporarily abandoned for more than ten (10) years.

6. KA.R. 82-3-111 imposes a 10-year limitation on the amount of time during which wells may be temporarily abandoned, but an exception to the 10-year limitation may be obtained pursuant to said regulation through an Application filed with the Commission pursuant to K.A.R.82-3-100. Applicant seeks such an exception.

7. On or about September 12, 2024, the Subject Well passed a Commission Staff-witnessed mechanical integrity test of the casing between the surface and a point within fifty (50) feet above the uppermost perforation or open hole in the well.

8. Applicant wishes to continue TA status for the Subject Well, because Applicant intends to use the well for the following purpose: Water source well for continued EOR.

Applicant submits the following information regarding the well in support of the
Application. Please see attached Exhibit "B", "C" and "D".

10. Applicant has included a map showing the locations of all producing, injection, temporarily abandoned, abandoned, and plugged wells located on the same leased premises as the Subject Well.

11. Based on the foregoing, Applicant requests the Commission grant an exception to the 10-year limitation, specifically to allow the Subject Well to remain eligible for temporary abandonment status for three (3) years following the expiration of the 10-year limitation. Applicant understands that the exception would be valid for three (3) years, but Applicant would

still need to apply annually to the Conservation Division District Office for approval of an application for temporary abandonment status.

12. Western Plains Resources holds leases over all minerals within 1/2 mile of the subject well.

13. Notice of this Application will be published pursuant to K.A.R. 82-3-135a. In addition, notice of the hearing to be held in this matter will be provided as prescribed by K.A.R. 82-3-135.

WHEREFORE, Applicant prays that this matter be granted administratively without a hearing, or in the alternative be set for hearing, and upon hearing that the Commission grant Applicant's request, for an exception to the K.A.R. 82-3-111 ten (10) year limitation, to allow the Subject Well to remain temporarily abandoned for three (3) years, subject to annual approval by the Conservation Division District Office of an application for temporary abandonment status.




RE: Odd Williams #3 WSW

To: The State Corporation Commission of the State of Kansas

Western Plains Resources, L.L.C. (Western Plains) is seeking an exception to the 10-year time limitation for a TA well status on its Odd Williams #3 WSW. The Odd Williams #3 is part of the Christabelle Unit. Please see Exhibit "C" for a map of the unit as of the acquisition by Western Plains. Exhibit "D" shows the current KCC well inventory and the corresponding status of each well on the unit. Estimated cost to plug the subject well is \$28,000. It is assumed that the cost to plug the remaining wells on the lease would be approximately the same, totaling \$756,000. Current production of the unit is approximately 42 bbl. per day. Estimated reserves in place are 57,650 bbls as calculated using decline curve analysis utilizing PHDWIN. As of the application of this exemption, the Odd Williams #3 has a composite bridge plug in place isolating lower previously utilized zones. Utilization as a water source well will require perforating of an acceptable water bearing formation and installing artificial lift to bring water to the surface/tanks and ultimately injected into an authorized injection well. Estimated cost to complete the stated project is \$80,000.
