CLOSING DOCKET

On February 18, 2022, Double “D” Oil Company, Inc. (Operator) filed an application as described by the above caption.¹ On April 4, 2022, Garth, Amy, Roger, Allyson, and George Howard Moon filed a protest.² On July 8, 2022, the Moons withdrew their protest.³

Under K.A.R. 82-3-400, the Conservation Division may take all actions with regard to injection wells without a Commission order, except for contested matters.⁴ Since the Moons have withdrawn their protest, and the regulatory protest period has elapsed without any other protests being filed against the application,⁵ this no longer appears to be a contested matter. Thus, the Presiding Officer concludes that further proceedings within this docket are unnecessary, and that closing this docket will not prevent Conservation Division Staff from taking any appropriate or necessary administrative actions related to Operator’s application.

Accordingly, this docket is closed. If any issue arises necessitating the reopening of this docket, then any party may request such at any time.
