The above captioned matter comes before the State Corporation Commission of the State of Kansas. Having examined the files and records, and being fully advised in the premises, the Commission finds and concludes as follows:

1. On May 17, 2018, the Commission issued a Penalty Order in the above captioned matter, labelling this matter as Docket Number 18-CONS-3296-CUIC.
2. The docket number assigned should instead be Docket Number 18-CONS-3296-CPEN, as this is a penalty matter, not an injection application.


THEREFORE, THE COMMISSION ORDERS:

- A. The May 17, 2018, Commission Penalty Order is amended to reflect the assignment of Docket Number 18-CONS-3296-CPEN to this proceeding, instead of Docket Number 18-CONS-3296-CUIC.
- B. The remainder of the Penalty Order is unchanged by this Order Nunc Pro Tunc.
- C. The Commission retains jurisdiction over the subject matter and the parties for the purpose of entering such further order or orders as it may deem necessary.
