RESPONSE TO MOTION TO VACATE PROPOSED DEFAULT ORDER

The Staff of the Kansas Corporation Commission (Staff and Commission, respectively) requests the Commission issue an order denying the Motion to Vacate Proposed Default Order (Motion) submitted by Quito, Inc. (Quito) in the captioned dockets. In support of its response, Staff states the following:

- 1. On April 26, 2024, Quito, Inc. (Quito) filed an application seeking an exception to the 10-year time limitation of K.A.R. 82-3-111 for its Tom Appleby #1, API #15-019-23675, and Tom Appleby #5, API #15-019-24284, wells (Subject Wells).
- 2. Upon receiving the application, Legal Staff noted that Quito is not licensed by the Commission to conduct oil and gas operations within the State of Kansas and has not held a valid license since its license expired May 30, 2020. On May 14, 2024, Commission Staff submitted a motion to dismiss the applications and close the captioned dockets. Quito failed to respond to Staff's motion. On June 13, 2024, the Commission issued an order consolidating dockets, designating presiding officer, and setting prehearing conference. Quito failed to attend the prehearing conference. On July 25, 2024, the Presiding Officer issued a proposed default order based on Quito's failure to attend the prehearing conference.

3. On August 1, 2024, Mr. John Horst filed an entry of appearance and filed its

Motion in the captioned dockets. In the Motion, it states that Quito was not aware of the

prehearing conference due to a clerical staff shortage. The Motion does not state that Quito did

not receive the Commission's order setting the prehearing conference, nor that Quito did not

receive Staff's motion to dismiss its applications in the captioned dockets. It is an operator's

responsibility to ensure that the mail is being consistently checked and a clerical staff shortage is

no excuse for missing the prehearing conference set by the Commission. The Motion also states

that Quito has applied for a new operator's license, but Quito has not had a valid license in over

four years as stated above. Plus, there is no indication that Quito is going to have a license

anytime in the near future due to its past compliance issues. There is no reason to approve an

application submitted by an unlicensed operator. Further, Quito has failed to provide any

legitimate reason why the proposed default order in the captioned dockets should be vacated.

WHEREFORE, for the reasons described above, Staff respectfully requests the

Commission issue an Order denying Quito's Motion and closing the docket in this matter.
