RESPONSE TO STAFF MOTION TO DISMISS

COMES NOW Veem Jade Oil & Gas LLC ("Operator"), and for its response to Staff's motion to dismiss filed June 21, 2018, in the captioned matter states as follows.

- 1. Operator filed this Application on January 2, 2018. The deadlines for protest, response or objection have expired. No protest, response, or objection has been received, and no action has been taken on this matter by the Commission.
- 1. Operator has provided updates to the Commission on the wells in this docket; most recently that all but one of the wells has been plugged, and a plugging application (Form CP-1) filed for the last open well--the Smith A #2. That well is set to be plugged at the plugging contractor's first available date.
- Operator has reported that the request made in its above-captioned Application is now moot. Operator has been in regular contact with said plugging contractor regarding when

the contractor will be able to plug the Smith A #2 well, and expects that well to be plugged in a matter of days.

3. Staff's Motion alleges that Operator's Application contained deficiencies. Operator denies any deficiencies in its Application, and affirmatively states that its filing and pursuit of the relief sought in the Application was in accordance with Commission requirements. However, the matter of the Application being moot due to Operator's actions of testing and plugging the wells, Operator agrees that dismissal is proper at this time.

WHEREFORE, Operator does not object to dismissal of the above Application at this time, and further requests such other relief as the Commission deems necessary and appropriate.
