ORDER

NOW, the above-captioned matter comes before the State Corporation Commission of the State of Kansas ("Commission"). Having examined its files and records, and being duly advised in the premises, the Commission finds and concludes as follows:

- 1. On December 12, 2006, Southwestern Bell Telephone, L.P. d/b/a AT&T Kansas ("SWBT") filed an application for approval of an interconnection agreement with DIECA Communications, Inc. d/b/a Covad Communications Company ("Covad") under the Telecommunications Act of 1996.
- 2. Approval of the agreement is sought under the terms of the Federal Telecommunications Act of 1996, Section 252(e). The parties believe that the Agreement is consistent with the public interest, convenience, and necessity and does not discriminate against any carrier not a party to the agreement. The parties contend that there are no outstanding issues between them that need the assistance of mediation or arbitration.
- 3. This agreement adopts a previously approved agreement, SWBT Docket No. 06-SWBT-237-IAT, with modifications. The modifications are negotiated replacements for Section

2.3.2 of the GT&C Appendix, the LNP Appendix, and the Collocation Appendix. The parties

state that there are no outstanding issues between the parties needing arbitration or mediation.

4. Both SWBT and Covad are registered with the Kansas Secretary of State's office

and are currently listed as "active and in good standing."

5. The Commission finds and concludes that the application for approval of the

interconnection agreement between SWBT and Covad should be approved.

IT IS, THEREFORE, BY THE COMMISSION ORDERED THAT:

A. Southwestern Bell Telephone, L.P.'s application for approval of its

interconnection agreement with DIECA Communications, Inc. d/b/a Covad Communications

Company is hereby approved.

B. The parties have fifteen days, plus three days if service of this order is by mail,

from the date this order was served in which to petition the Commission for reconsideration of

any issue or issues decided herein. K.S.A. 66-118; K.S.A. 2005 Supp. 77-529(a)(1).

C. The Commission retains jurisdiction over the subject matter and the parties for the

purpose of entering such further order, or orders, as it may deem necessary.
