ORDER CLOSING DOCKET

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having examined the pleadings submitted and being duly advised in the premises, the Commission finds as follows:

I. BACKGROUND

- On April 11, 2016, Martie Floyd (Complainant) filed a Formal Complaint 1. (Complaint) against Atmos Energy (Atmos) with the Commission. The Complainant asserted that Atmos requires electronic metering for all transportation customers, which is not possible in rural areas of Kansas where phone lines are not easily accessible.²
- 2. On August 4, 2016, the Commission approved an Order Adopting Legal Memorandum, which ordered the Formal Complaint to be served upon Atmos for an Answer and directed Staff to investigate this matter and submit a Report and Recommendation to the Commission.³
- 3. On September 5, 2016, the Complainant mailed a letter to the Commission Consumer Protection Division requesting the withdrawal the Complaint, stating that the

Complainant and Atmos reached a mutually acceptable resolution of the matters raised in the Complaint.⁴ A copy of the letter of September 5, 2016 is attached hereto as Attachment A.

II. FINDINGS AND CONCLUSIONS

4. The Commission finds and concludes that the record in this proceeding supports that all outstanding issues between Complainant and Atmos complained of in this docket have been resolved. Therefore, the Commission finds it appropriate to grant Complainant's request to withdraw its present complaint before the Commission, and close the present docket.

IT IS, THEREFORE, BY THE COMMISSION ORDERED THAT:

- (A) Complainant's request to withdraw its complaint in this matter is hereby granted.
- (B) The above-captioned docket is hereby closed.
- (C) The parties have fifteen (15) days, plus three (3) days if service of this order is by mail, from the date this order was served in which to petition the Commission for reconsideration of any issue or issues decided herein. K.S.A. 66-118b; K.S.A. 2015 Supp. 77-529(a)(1).
- (D) The Commission retains jurisdiction over the subject matter and the parties for the purpose of entering such further orders as it may deem necessary and proper.
