**ORDER HOLDING REQUEST FOR RECONSIDERATION IN ABEYANCE**

On February 14, 2025, Somerset requested reconsideration of the Commission's February 6, 2025, Order on Motion for Preliminary Order. The Commission finds that its order was not a final order under the Kansas Administrative Procedure Act,<sup>1</sup> and thus there is no statutory timeframe by which it must render a decision on the request.

On February 17, 2025, Commission Staff responded to Somerset's request for reconsideration. As the Commission understands things, the parties have reached an agreement that will likely resolve the captioned dockets, and the parties are not opposed to the February 14, 2025, motion being held in abeyance. Accordingly, the request for reconsideration is held in abeyance, and the procedural schedule set out in the February 6, 2025, order is stayed.
