



AT&T Kansas will provide video programming throughout its footprint using the following three technological platforms: (1) AT&T U-VERSE (IPTV); (2) AT&T Homezone; and (3) AT&T DISH Network. One or more of these options will be available to all customers in the footprint within five (5) years of the date this application is approved. Additional detail, including drawings, of these three service platforms are attached. As technology advances, additional service platforms may become available.



Satellite Television. Through an expanded agreement with EchoStar Communications, customers choose from a variety of AT&T | DISH Network satellite entertainment programming packages.
