During your Assurance Wireless application, you will be redirected to the National Verifier website, which is Lifeline's centralized application system. It validates your identity and address, and determines your eligibility for Lifeline.

### **Providing Proof of Eligibility**

If you're applying through a government program or based on your income, the National Verifier might automatically check your details using databases for programs like Medicaid, SNAP, Housing Assistance (FHAP) and Veterans Benefits (VA). If they can't find your information, you'll need to upload proof of program enrollment or income documents.

### **Ready. Set. GO.**

Once your application has been processed and approved, we will keep you in the know on your next steps. If you have chosen to buy a low-cost phone, you will be directed to choose and pay for your new phone.

### **Activate My Account**

# State Eligibility Requirements

## Program-Based

You may be eligible if you participate in any of the following government programs:

- Supplemental Nutrition Assistance Program (SNAP) (Food Stamps)
- Medicaid
- Supplemental Security Income (SSI)
- Federal Public Housing Assistance (FPHA)
- Veterans Pension or Survivors Benefit Programs
- Tribal Specific Programs
  - Bureau of Indian Affairs (BIA) General Assistance
  - Tribal Temporary Assistance for Needy Families (Tribal TANF)

## Income-Based

You may be eligible if your income is 135% or less than the Federal Poverty Guidelines.

**Lifeline Example:** For household of nine (9) people, the Yearly Income allowed = \$0 - \$80,528 (\$73,103 + \$7,425).
