**SIERRA CLUB, VOTE SOLAR, AND CLIMATE AND ENERGY PROJECT'S
OBJECTION TO THE NON-UNANIMOUS STIPULATION AND AGREEMENT AND
THE JOINT MOTION TO APPROVE THE SAME**

Pursuant to K.A.R. § 82-1-230a(c), Sierra Club, Vote Solar, and Climate and Energy Project hereby provide notice to the Kansas Corporation Commission ("Commission") and the parties in the above-captioned docket of their Objection to the Non-Unanimous Stipulation and Agreement and the Joint Motion to Approve the Same. Sierra Club, Vote Solar, and Climate and Energy Project state as follows:

1. On February 1, 2018, Westar Energy, Inc. and Kansas Gas and Electric Company (collectively, "Westar") filed a Joint Application requesting approval to make certain changes to their charges and rates for electric services.
2. On July 16, 2018, Westar and several parties to this docket submitted a Joint Motion to Approve Non-Unanimous Stipulation and Agreement ("Joint Motion") and a Non-Unanimous Stipulation and Agreement ("NSA").
3. Sierra Club, Vote Solar, and Climate and Energy Project are not signatories to, and oppose, the Joint Motion and NSA, and intend to participate actively in the evidentiary hearing scheduled to commence on Monday, July 23, 2018.



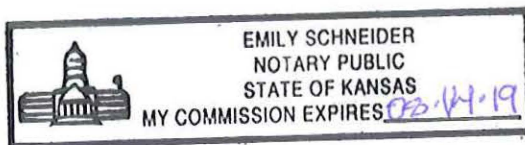
