On April 28, 2021, Pickrell Drilling Company, Inc. motioned both to intervene in this docket and to protest Palomino's April 15, 2021, application. On June 3, 2021, the Commission held Pickrell's motion in abeyance, designated myself as presiding officer, and set a June 17, 2021, prehearing conference. On June 7, 2021, Pickrell motioned to withdraw its protest; on June 9, 2021, the motion was granted. Pickrell's motion to intervene remained unresolved.

Under K.S.A. 77-521 and K.A.R. 82-1-225, the presiding officer finds Pickrell's intervention to be in the interests of justice, and that it will not impair the orderly and prompt conduct of these proceedings. Pickrell's motion to intervene is granted.
