## PREHEARING OFFICER ORDER CLOSING DOCKET

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having reviewed the pleadings and record, the Prehearing Officer makes the following findings:

- 1. On October 4, 2018, the Commission issued a *Penalty Order* against Liberty Operations & Completions, Inc. (Operator), concluding the Operator committed one violation of K.A.R. 82-3-407.<sup>1</sup>
  - 2. On October 18, 2018, the Operator requested a hearing.<sup>2</sup>
  - 3. On March 5, 2019, the Operator withdrew its request for a hearing.<sup>3</sup>
- 4. Based on the Operator's withdrawal of its request for a hearing, the Prehearing Officer finds further proceedings are unnecessary.

### THEREFORE, THE PREHEARING OFFICER ORDERS:

A. The procedural schedule in this docket, including the evidentiary hearing, is canceled.<sup>4</sup>
