

TO: All Oil and Gas Producers, Unleased Mineral Interest Owners, Landowners, and all persons whosever concerned.

You are hereby notified that F.G. Holl Company, L.L.C. is filing an application with Kansas Corporation Commission for an exception to the 10-year time limitation for well temporary abandonment status for its Ward Feed Yard "A" #1-19 well located at NE NWNW/4 of Section 19-Township 21 South and Range 15 West, Pawnee County, Kansas

Any persons who object or protest this application shall be required to file their concerns with the Conservation Division of the State Corporation Commission of the State of Kansas within 15 days from the date of the publication. If no protests are received, this application may be granted through a summary proceeding. If valid protests are received, this matter will be set for hearing.
