
**STATUS UPDATE TO COMPLIANCE AGREEMENT**

On July 16, 2019, the Commission issued an Order Approving Compliance Agreement (Agreement) in this docket. The Agreement provides that upon good cause shown, Operator may receive an extension of time to achieve compliance for up to 30 days from the applicable deadline, if Operator requested an extension at least seven days prior to the applicable deadline.<sup>1</sup>

On September 20, 2019, Operator requested an extension of time from the initial deadline in order to plug, return to service, or repair and TA the well(s) that are subject to this deadline. The District #3 Supervisor recommends approving the Operator's extension request. The District Supervisor's email correspondence dated September 23, 2019 is attached hereto and incorporated by reference.

Staff hereby recommends approving the Operator's request for an extension of time to achieve compliance.

Per the commission ordered agreement, section B, paragraph #3, the maximum extension that can be granted is 30 days, October 20, 2019. I will make the recommendation for the status update extending your initial deadline to October 20, 2019 to legal staff who will bring it before the Commission for approval.
