**ORDER GRANTING MOTION  
TO TERMINATE COMPLIANCE AGREEMENT**

The Commission rules as follows:

1.     On June 21, 2022, Commission Staff motioned to terminate the compliance agreement in this docket. The same day, Staff motioned for approval of a compliance agreement with TexxStar, Inc. (License #35941) in Docket 22-3471.

2.     If both motions are approved, then the 93 remaining unplugged wells on Operator's license, which are subject to the compliance agreement in this docket, will be transferred to TexxStar, and become subject to that compliance agreement. Further, assuming TexxStar meets the terms of its agreement, all 93 wells will be brought into compliance with K.A.R. 82-3-111 by June 2028, rather than by December 2033.

3.     The Commission finds granting Staff's motion in this docket to be in the public interest; Staff's motion in Docket 22-3471 will also be granted today, via an order in that docket.

**THEREFORE, THE COMMISSION ORDERS:**

- A.     Staff's motion to terminate the compliance agreement in this docket is granted.
- B.     Any party may file and serve a petition for reconsideration pursuant to the requirements and time limits established by K.S.A. 77-529(a)(1).<sup>1</sup>
