JOINT MOTION FOR PROCEDURAL SCHEDULE

The Staff of the State Corporation Commission of the State of Kansas (Staff), Westar Energy, Inc. and Kansas Gas and Electric Company (collectively, Westar Energy), Citizen's Utility Ratepayer Board, Occidental Chemical Corporation, Cargill Incorporation, Hawker Beechcraft Corporation, and the Boeing Company (collectively, the Parties), by and through their counsel, file this joint motion requesting the Commission adopt the procedural schedule negotiated and agreed upon by the Parties in this matter. In support of its Motion, the Parties state as follows:

1. On March 22, 2012, the Commission issued a Suspension Order and Order Granting Temporary Waiver suspending the effective date of Westar Energy's requested tariff revisions in this docket for 240 days, until October 22, 2012.

2. All of the parties in this docket have reached an agreement on the following proposed procedural schedule:



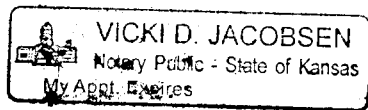


