JOINT MOTION FOR PROCEDURAL SCHEDULE

COME NOW the Wolf Creek Nuclear Operating Corporation (“WCNOC”), Kansas Gas and Electric Company d/b/a Westar Energy (“Westar”), Kansas City Power & Light Company (“KCP&L”), Kansas Electric Power Cooperative, Inc. (“KEPCo”), the Citizens’ Utility Ratepayer Board (“CURB”) and the Staff of the State Corporation Commission of the State of Kansas (“Staff” and “Commission,” respectively) collectively referred to as “Joint Movants,” and hereby move the Commission for an order establishing a procedural schedule. In support of their motion, Joint Movants state the following:

1. On September 1, 2017, WCNOC, Westar, KCP&L and KEPCo jointly submitted their pleading concerning the Decommissioning Financing Plan for the Wolf Creek Generating Station (“Wolf Creek”). Such Plan includes the 2017 triennial Decommissioning Cost Study for Wolf Creek.
2. On September 19, 2017, the Commission granted the Citizens’ Utility Ratepayer Board intervention in the instant proceeding. The Commission also issued an Order Designating Prehearing Officer, as well as Protective and Discovery Orders.
3. The proposed procedural schedule agreed to by Joint Movants is as follows:

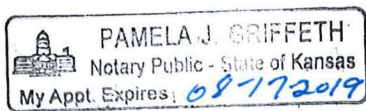
