ORDER ALLOWING CORPORATE OFFICER AS LEGAL REPRESENTATIVE

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having reviewed its files and records, and being fully advised in the premises, the Commission makes the following findings and conclusions:

- 1. On August 29, 2018, the Commission issued a Notice of Violation (Invoice No. H000576294) to Mid-America Road Builders, Inc. (Mid-America), stemming from a Kansas Highway Patrol (KHP) roadside vehicle inspection conducted on August 27, 2018. The penalty amount was \$150.
- 2. On August 31, 2018, the Commission issued another Notice of Violation (Invoice No. H000576335) to Mid-America,⁴ stemming from a separate roadside inspection conducted on August 27, 2018.⁵ The penalty amount was \$150.⁶

- 3. On October 25, 2018, the Commission received Mid-America's Request for Hearing, dated October 23, 2019.⁷
- 4. On March 7, 2019, the Commission issued its *Order Designating Prehearing Officer and Setting Prehearing Conference*, scheduling a Prehearing Conference for March 26, 2019. The Prehearing Conference was subsequently continued until April 16, 2019.
- 5. On March 25, 2019, Mid-America moved the Commission to allow Mid-America's President, Ken Pratt, to represent Mid-America *pro se* in all current and future matters associated with the instant docket.¹⁰ Mid-America stated that Mr. Pratt is the corporation's President and Board Director and that the total penalty assessed against Mid-America is \$300.¹¹ Mid-America "pray[ed] this Commission to set aside its requirement as stated in Item E in its Order Designating a Prehearing Officer and Setting a Prehearing Conference, dated March 7, 2019," which required Mid-America to be represented by a Kansas licensed attorney.¹²
- 6. Generally, K.A.R. 82-1-228 requires a corporation to appear by legal counsel. However, for civil penalties of \$500 or less, K.S.A. 66-1,142b(e) requires the Commission to allow a duly authorized representative of the corporation . . . to enter an appearance and represent the corporation as a motor carrier.
- 7. The civil penalty assessed against Mid-America is less than \$500, and thus, in accordance with K.S.A. 66-1,142b(e), the Commission finds that as a duly authorized representative of Mid-America, Mr. Pratt may represent Mid-America before the Commission.

B. Any party may file and serve a petition for reconsideration pursuant to the requirements and time limits established by K.S.A. 77-529(a)(1).¹³

C. The Commission retains jurisdiction over the subject matter and parties for the purpose of entering further orders as it may deem necessary.
