The Prehearing Officer makes the following findings:

1. On April 25, 2019, the Commission issued a *Penalty Order* against Micro Oil, LLC (Operator) for seventeen violations of K.A.R. 82-3-409 because Operator failed to file annual fluid injection reports for seventeen wells in Allen County.¹

2. On May 28, 2019, Operator requested a hearing.² On July 11, 2019, Commission Staff

filed a Motion to Approve Settlement Agreement, attaching the agreement, which was signed by Staff

and Operator. The matter is currently scheduled for a July 12, 2019, prehearing conference.³

3. The Prehearing Officer finds the currently scheduled prehearing conference is

unnecessary while the Commission is considering Staff's motion.

THEREFORE, THE PREHEARING OFFICER ORDERS:

A. The prehearing conference scheduled for July 12, 2019,⁴ is cancelled.
