## **ORDER APPROVING MODIFICATION**

NOW, the above-captioned matter comes before the State Corporation Commission of the State of Kansas ("Commission"). Having examined its files and records, and being duly advised in the premises, the Commission finds and concludes as follows:

1. On November 15, 2005, in Docket Nos. 06-IRHT-272-COC and 06-IRHT-273-COC, the Commission granted Ironhorse Services, LLC a certificate of convenience and authority to provide local and interexchange telecommunication services in the state of Kansas. On October 10, 2006, in Docket Nos. 07-IRHT-361-COC and 07-IRHT-362-COC, the Commission granted Ironhorse Service, LLC a name change to Avid Communications, LLC ("Avid"). Avid is registered with the Kansas Secretary of State's office and is currently "active and in good standing."

On April 20, 2006, Ironhorse Services, LLC chose to adopt an MFN agreement 2. approved by the Commission during arbitration proceedings to develop successor agreements for the Kansas 271 Interconnection Agreement.

On February 2, 2007, Southwestern Bell Telephone, L.P. d/b/a AT&T Kansas 3. ("SWBT") filed an application for a modification to the interconnection agreement previously approved between SWBT and Avid Communications, LLC f/k/a Ironhorse Services, LLC under the Telecommunications Act of 1996.

4. This modification to the agreement is consistent with the provisions of Section 252(e) of the Federal Telecommunications Act of 1996 and amends, modifies, and supersedes the agreement previously negotiated and filed with the Commission on May 2, 2006. This amendment reflects a name change from Ironhorse Services, LLC to Avid Communications, LLC. Except as modified herein, all other terms and conditions of the underlying agreement remain unchanged and in full force.

5. Staff has reviewed this modification to the K2A Interconnection Agreement between SWBT and Avid and finds no evidence to conclude this agreement discriminates against any carrier not a party to the agreement nor is it inconsistent with the public interest, convenience, and necessity.

6. The Commission finds and concludes that the application for approval of a modification to the interconnection agreement between SWBT and Avid should be approved.

## IT IS, THEREFORE, BY THE COMMISSION ORDERED THAT:

A. Southwestern Bell Telephone, L.P.'s application for approval of a modification to its interconnection agreement with Avid Communications, LLC f/k/a Ironhorse Services, LLC is hereby approved.

B. The parties have fifteen days, plus three days if service of this order is by mail, from the date this order was served in which to petition the Commission for reconsideration of any issue or issues decided herein. K.S.A. 66-118; K.S.A. 2006 Supp. 77-529(a)(1).

C. The Commission retains jurisdiction over the subject matter and the parties for the purpose of entering such further order, or orders, as it may deem necessary.
