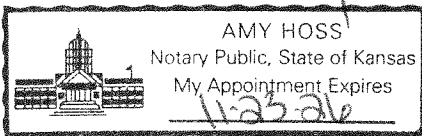

### NOTICE OF FILING APPLICATION

RE: Murfin Drilling Co., Inc. - Application to Amend Injection Permit for disposal into the Zeman LKC Unit 101D disposal well, located in Russell County, Kansas.

TO: All Oil and Gas Producers, Unleased Mineral Interest Owners, Landowners, and all persons whomever concerned.

You, and each of you, are hereby notified that Murfin Drilling Company, Inc. has filed an application to amend the maximum authorized injection rate to 4,000 bbl/day from the current rate of 2,000 bbl/day keeping the authorized maximum injection pressure of 50 psi for the injection of salt water into the Arbuckle at the Zeman LKC Unit 101D located in the NW NW SW of Sec. 9-14s-12w, Russell County, Kansas.

Any persons who object to or protest this application shall be required to file their objections or protest with the Conservation Division of the State Corporation Commission of the State of Kansas within thirty (30) days from the date of this publication. These protests shall be pursuant to Commission regulations and must state specific reasons why the grant of the application may cause waste, violate correlative rights or pollute the natural resources of the State of Kansas.

All persons interested or concerned shall take notice of the foregoing and shall govern themselves accordingly.
