For Issuance of Subpoena in Aid of an Investigation requesting the Commission open a docket for the purposes of issuing a Subpoena Duces Tecum in order to aid an ongoing investigation of the Transportation Division.

3. On August 7, 2017, Staff filed the Return of Completed Subpoena.

4. On August 25, 2017, Staff filed a Confidential Affidavit of Custodian of Business Records.

5. The Commission finds and concludes that the closure of the above docket is necessary and proper to promote the State's interest in the efficient administration of Kansas statutes and the Commission's regulations.

6. The Commission further finds and concludes that, from the record, it does not appear that any party to the matter in this docket will be unduly burdened or prejudiced by the closure of the above docket.

7. The Commission finds and concludes that the above docket should be closed.

IT IS THEREFORE, BY THE COMMISSION ORDERED THAT:

A. For the reasons set out above, the captioned docket is hereby closed.

B. The parties have fifteen (15) days, plus three (3) days if service of this Order is by mail, from the date this Order was served in which to petition the Commission for reconsideration of any issue or issues decided herein. K.S.A. 66-118b; K.S.A. 2016 Supp. 77-529.

C. The Commission retains jurisdiction over the subject matter and the parties for the purpose of entering such further orders as it may deem necessary and proper.
