PETITION TO INTERVENE

COMES NOW, the Western Kansas Industrial Electric Consumers ("WKIEC") and moves the Corporation Commission of the State of Kansas ("Commission") for an Order permitting it to intervene in the above-captioned matter. In support of its Petition, WKIEC states and alleges as follows:

- 1. WKIEC is a voluntary association of Western Kansas Industrical consumers which represents the interests of those consumers in utility proceedings. Attached hereto and incorporated herein by reference is a list of those industrial consumers and the individual distribution cooperatives or company that provides them with electric service (Appendix A).
- 2. On January 8, 2013, Mid-Kansas Electric Company, LLC ("MKEC") filed its Application for Approval of a Debt Service Coverage ("DSC") Formula Based Rate-Making ("FBR") Pilot Plan. The "DSC-FBR Plan" to be effective for the geographic territory served by its memberowner, Southern Pioneer Electric Company ("Southern Pioneer"). While this is one member, this is an MKEC rate and would set a precedent for a DSC-FBR Plan for other member-owner geographic territories.
- 3. WKIEC is requesting permission to intervene in this docket to represent the interests of large industrial customers specifically, National Helium and Air Products are ratepayers in the geographic territory served by Southern Pioneer. Likewise, adoption of this DSC-FBR Plan could

establish a precedent for the MKEC. The same plan was proposed in 12-MKEE-380-RTS and opposed for various reasons. Ultimately, the parties reached settlement on a revenue requirement in the 380 docket and Mid-Kansas abandoned its request for the DSC rate-making plan as a part of that rate proceeding. These parties were intervenors in that docket.

- 4. The representation of WKIEC's interest in this proceeding by existing parties is, or may be inadequate and no other party will represent the interests of large industrial customers, except for WKIEC.
- 5. Large industrial ratepayers, whose interests WKIEC represents, particularly National Helium and Air Products will be bound by any Commission Order or activity in this proceeding and will or may be adversely affected thereby. Likewise, to the extent this docket would establish a precedent involving "DSC-FBR Plans" that would adversely affect the entire group.

WHEREFORE, WKIEC respectfully requests that this Commission grant its Petition for Intervention in this docket.
