NOTICE OF AMENDED SCHEDULE

COME NOW the Wolf Creek Nuclear Operating Corporation (“WCNOC”), Evergy Metro, Inc. d/b/a Evergy Kansas Metro [f/k/a Kansas City Power & Light Company] (“Evergy Kansas Metro”), Evergy Kansas Central, Inc. [f/k/a Westar Energy, Inc.] and Evergy Kansas South, Inc. [f/k/a Kansas Gas and Electric Company] (collectively referred to herein as “Evergy Kansas Central”); and all three collectively referred to herein as “Companies”)¹, and Kansas Electric Power Cooperative, Inc. (“KEPCo”) (collectively referred to as the “Parties”) and, for their *Notice of Amended Schedule* (“Notice”), states as follows:

1. On September 1, 2023, the Parties filed their *Joint Pleading Regarding Decommissioning Financing Plan* (“Decommissioning Plan”) with the State Corporation Commission for the State of Kansas (“Commission”).
2. Included as part of the Decommissioning Plan was Attachment 4-Utility Funding Plans (“Attachment 4”).
3. After filing, the Company discovered incorrect inputs in the funding model for management fees as reflected in Schedule B (“Schedule B”) of Attachment 4.
4. Pursuant to the information provided in the paragraph above, attached please find an **Amended Schedule B** (“2023 Amended Funding Analysis”).
