PRESIDING OFFICER ORDER REGARDING ELECTRONIC SERVICE

At an April 28, 2022, prehearing conference, all participating entities consented to the electronic service of all documents¹ and orders.² Accordingly, the Presiding Officer rules as follows:

1. Service of all documents and orders may be made by email. To the extent practicable, any electronically served document or order shall be attached to the email and served in pdf format. Service of orders is complete upon transmission.³ Participating entities are encouraged to make sure large pdf files do not result in delivery failure and to work together to resolve any email-based service issues. 2. Filing of documents with the Commission must still be done either through the Commission's "e-filing express" system, or by mail or hand delivery to the Commission.⁴ The Commission strongly encourages parties to file through the "e-filing express" system,⁵ but if a document is filed by mail or hand delivery, only the original copy must be supplied.⁶
