**ORDER CLOSING DOCKET**

The above-captioned matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and decision. Having examined its files and records, and being duly advised in the premises, the Commission finds and concludes as follows:

1.     On September 16, 2022, United Telephone Companies of Kansas d/b/a CenturyLink (CenturyLink) filed a request to approve a revised tariff pages that discontinue auto-renewals for the Company Line Volume Plan previously known as CenturyLink Line Volume Plan.<sup>1</sup>

2.     K.S.A. 66-117 provides no change in tariffs shall occur except by filing them with the Commission prior to becoming effective. CenturyLink's revised tariff pages state that they anticipate an effective date of October 19, 2022.<sup>2</sup>

3.     The Commission Staff reviewed the tariff filing and accepted it as filed. Accordingly, the docket should be closed.
