**ORDER CLARIFYING FILING REQUIREMENTS**

NOW, the above-captioned matter comes before the State Corporation Commission of the State of Kansas ("Commission") for consideration and decision. Having reviewed its files and records and being duly advised in the premises, the Commission makes the following findings:

1. In an order dated August 8, 2012, in this docket, the Commission granted YourTel America, Inc. ("YourTel") Eligible Telecommunications Carrier ("ETC") status in additional service areas for the purpose of receiving low-income Federal Universal Service Fund ("FUSF") support and Kansas Universal Service Fund ("KUSF") support when providing universal service via wireless technology.

2. On November 15, 2012, in this docket, the Commission ordered YourTel to submit quarterly reports to the Commission listing the number of Kansas customers subscribing to each calling plan where a state and/or federal Lifeline subsidy was being applied. The reports are due by the 15th of the month following the end of the quarter (e.g. January 15th, April 15th, July 15th, and October 15th), with the first report due by January 15, 2013.

3. However, the November 15, 2012 Order did not specify where to file the aforementioned quarterly reports. The Commission finds that the quarterly reports should be filed as compliance filings in a compliance docket opened by YourTel. YourTel shall include a cover page on all such filings, captioned "In the Matter of YourTel America, Inc. Compliance Filings as required by Commission Order dated November 15, 2012, in Docket No. 12-TPCT-768-ETC." To the extent that any such filing or portion thereof is confidential, YourTel shall adhere to K.A.R. 82-1-221a.

**IT IS, THEREFORE, BY THE COMMISSION ORDERED THAT:**

A. YourTel shall make its required compliance filings as set forth in paragraphs 2 and 3 above. The first compliance filing is due January 15, 2013.

B. The parties have fifteen (15) days, plus three (3) days if service of this order is by mail, from the date this order was served in which to petition the Commission for reconsideration of any issue or issues decided herein. K.S.A. 66-118b; K.S.A. 77-529(a)(1).

C. The Commission retains jurisdiction over the subject matter and parties for the purpose of issuing such further order, or orders, as it may deem necessary.
