MOTION FOR EXTENSION OF FILING DATE

COME NOW Colleen R. Harrell, and James M. Caplinger of JAMES M. CAPLINGER, CHTD., and move the Commission for an extension of the filing date for the information ordered to be filed in this docket and provided to Staff by WestLink Communications, LLC, and United Wireless Communications, Inc., (collectively, "the companies"). In support of the motion, the companies show the Commission, as follows:

1. On August 27, 2013, the Commission issued its order opening this docket and requiring certain classes of entities receiving funds from the Kansas Universal Service Fund (KUSF) to file certain information in this docket and to provide that information to Staff in electronic format. The date by which the Commission ordered this information to be filed, and provided to Staff, is October 18, 2013.

2. The companies requesting, by this motion, an extension of the filing date are both competitive eligible telecommunications carriers and, as such, were ordered to file Attachments A, C, and E.

3. On August 9, 2013, United Wireless Communications acquired WestLink Communications; WestLink is now a wholly-owned subsidiary of United Wireless. United Wireless informed the Commission of this transaction via letter dated August 27, 2013.

4. Because of the acquisition, WestLink and United were transitioned to a new billing system. This billing system has different capabilities than either previous billing system to

identify lines required for completing attachments A, C, and E. Company personnel are working on completing the information manually, but need additional time in which to finalize the information.

5. In addition, a key person involved in this task has been ill and unable to work. And, finally, a family emergency occurring on October 18 has also affected the work.

6. Counsel for WestLink and United have spoken with Commission Staff that would be receiving and compiling the electronic information. Staff does not have an objection to an extension of time for WestLink and United. The companies have committed to Staff that they should be able to provide the WestLink information to Staff no later than Friday, October 25, 2013, and the United Wireless information no later than Friday, November 1, 2013.

WHEREFORE, WestLink and United request an extension of the deadline to provide the appropriate attachments to Staff and to file in the docket, and for such other and further relief as the Commission deems just and equitable.

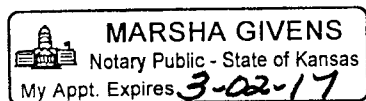


