Informational Notice Regarding the Merger of IdeaTek Telcom, LLC

Ms. Retz:

By this letter, IdeaTek Telcom, LLC (the "<u>Company</u>") notifies the State Corporation Commission of the State of Kansas (the "<u>Commission</u>") of a planned change in control. Since Commission approval is not required for the Merger, this letter is submitted only for informational purposes.

The Company is authorized by the Commission pursuant to (i) that certain Order and Certificate, issued in Docket No. 06-WLDT-1005-COC, dated May 1, 2006, by and between Company under its former name, Wildflower Telecommunications, LLC; (ii) that certain Order Approving Certificate, issued in Docket No. 08-WLDT-1077-COC, dated October 14, 2008, by and between the Company under its former name, Wildflower Telecommunications, LLC (iii) that certain Order Granting High-Cost ETC Designation Expansion, issued in Docket No. 21-WLDT-343-ETC, dated May 20, 2021; and (iv) that certain Order Granting Eligible Telecommunications Carrier Status issued in Docket No. 19-WLDT-102-ETC, dated December 18, 2018 (collectively, the "Authorizations").

On February 22, 2025, Ideatek Holdings, LLC ("IdeaTek") the parent of the Company, Last Dance Intermediate III, LLC ('Parent'), Last Dance Merger Sub, LLC ('Merger Sub') and, solely in their capacity as member representatives, Daniel Friesen and Arnoud Krijt, entered into an Agreement and Plan of Merger (the "Merger Agreement"). Pursuant to the Merger Agreement, subject to customary closing conditions (including the receipt of required regulatory approvals), Merger Sub will merge with and into IdeaTek, and IdeaTek will continue as the surviving company and a wholly-owned subsidiary of Parent (the "Merger"). Upon completion of the Merger, the Company will remain a direct, wholly owned subsidiary of IdeaTek and will be an indirect subsidiary of Parent. The proposed Merger involves only a change in indirect ownership of the Company and will not impact the Company's performance or responsibilities under the Authorizations. Subject to the aforementioned closing conditions, the Merger may close as early as early May, 2025.
