KANSAS GAS SERVICE’S QUARTERLY AND MONTHLY
COMPLIANCE FILING

Kansas Gas Service, a Division of One Gas, Inc., (“Kansas Gas Service” and “Company”), in compliance with the Commission’s Order dated June 21, 2001, in Docket No. 106,850-U/75-GIMC-009-GIG (“Order”), respectfully submits its compliance filing for the month of August, 2021. As permitted by K.S.A. 66-1220a, K.A.R. 82-1-221a and the *Protective Order* issued in this docket,¹ Kansas Gas Service has designated portions of this filing as “*CONFIDENTIAL*”. The Company states and reports as follows:

I. DESCRIPTION OF KANSAS GAS SERVICE

1. Kansas Gas Service is a natural gas public utility operating in the state of Kansas pursuant to certificates of convenience and necessity issued by the Commission. Kansas Gas Service’s principal place of business within the state of Kansas is located at: 7421 West 129th Street, Overland Park, Kansas 66213.

II. NATURE OF FILING

2. Pursuant to the Order, and on a monthly basis, Kansas Gas Service is required to file a summary of all gas purchase contracts entered into each month by using


