



3. Pursuant to Kansas rules, attached is the affidavit of Dari R. Dornan in support of this Motion.





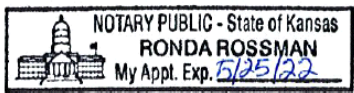


