ORDER GRANTING CURB'S PETITION TO INTERVENE

This matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and decision. Having reviewed the pleadings and record, the Commission makes the following findings:

1. On October 27, 2014, Westar Energy, Inc. and Kansas Gas and Electric Company (Westar Energy) filed an Application with the Kansas Corporation Commission seeking approval to revise their Project Deserve Program.¹

2. On October 28, 2014, the Citizens' Utility Ratepayer Board (CURB) filed its Petition to Intervene, citing its statutory authority to represent residential and small commercial ratepayers.² CURB explains the rates paid and the services received by residential and small commercial ratepayers under Westar Energy's proposed revisions to its Project Deserve Program may be substantially affected by any Commission order or activity in this proceeding.³

3. The Commission finds CURB has demonstrated an interest in this proceeding. Therefore, pursuant to K.S.A. 77-521, the Commission grants CURB's Petition for Intervention.
