The above-captioned matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and decision. Having examined its files and records, and being duly advised in the premises, the Commission finds and concludes as follows:

I. JURISDICTION AND BACKGROUND

1. The Commission is given full power, authority and jurisdiction to supervise and control electric public utilities, as defined in K.S.A. 66-101a, doing business in Kansas, and is empowered to do all things necessary and convenient for the exercise of such power, authority and jurisdiction.¹ "[A]ll incidental powers necessary to carry into effect the provisions of [the Electric Public Utilities Act, K.S.A. 66-101 *et seq.*] are expressly granted to and conferred upon the commission."²

2. K.S.A. 66-101h provides the Commission with general supervision over electric public utilities in Kansas. The Commission is obligated to examine and inspect the condition of

each electric public utility, its equipment, the manner of its conduct and its management with reference to the public safety and convenience.³

3. Commission Staff (Staff) submitted a Report and Recommendation (R&R) dated April 17, 2019, recommending the Commission open a general investigation in the operations of Westar Energy, Inc. (Westar) regarding an accident that occurred due to a steam release at the Jeffrey Energy Center on June 3, 2018, in St. Mary's, Kansas. Staff's R&R is attached hereto and herein incorporated by reference.⁴

4. Staff explained in its R&R that opening a general investigation docket will allow Staff to track costs associated with its investigation, report its findings to the Commission, and allow the Commission to rule on any matters pertaining to the investigation. Staff notes the primary objective of its investigation will be to determine the root cause of the accident and recommend any actions to be taken by Westar to minimize the possibility of recurrence of a similar accident.

II. FINDINGS AND CONCLUSIONS

5. The Commission finds and concludes Staff's recommendation in its April 17, 2019 R&R to be reasonable and adopts the same. Accordingly, the Commission finds and concludes a general investigation docket shall be opened to permit Staff to conduct its investigation as appropriate.

IT IS, THEREFORE, BY THE COMMISSION ORDERED THAT:

A. A general investigation into the operations of Westar regarding an accident that occurred due to a steam release at the Jeffrey Energy Center on June 3, 2018, in St. Mary's Kansas is hereby opened.

RECOMMENDATION:

On June 3, 2018, a superheated steam release occurred in the steam drum room of Jeffrey Energy Center (JEC) Unit 3 during a routine startup of the facility. Two Westar Energy (Westar) employees were exposed to the superheated steam, which caused severe bums and subsequent death of the employees. K.S.A. 66-101h¹ obliges the Commission to inspect the condition of an electric public utility's equipment, manner of its conduct, and management with respect to public safety.

In order to fully investigate the cause of the accident, Staff recommends the Commission open a General Investigation into the above captioned matter. The proposed Docket will allow Staff to track costs associated with this investigation, report its findings to the Commission, and allow the Commission to rule on any matters pertaining to the investigation. A primary objective of the investigation will be to determine the root cause of the accident and recommend any actions to be taken by Westar to minimize the possibility of recurrence of a similar accident.

The commission shall have general supervision of all electric public utilities doing business in this state and shall inquire into any neglect or violations of the laws of this state by any electric public utility or by the officers, agents or employees thereof. From time to time, the commission shall carefully examine and inspect the condition of each electric public utility, its equipment, the manner of its conduct and its management with reference to the public safety and convenience. Nothing in this section shall be construed as relieving any electric public utility from its responsibility or liability for damage to person or property.
