JOINT MOTION FOR APPROVAL OF PROCEDURAL ORDER

American Energies Gas Service, LLC ("AEGS"), Staff of the Kansas Corporation Commission ("Staff"), and Citizens' Utility Ratepayer Board ("CURB") (collectively, the "Parties") move the Kansas Corporation Commission ("Commission") for approval of the proposed procedural order which is attached hereto. In support of this Joint Motion, the Parties state as follows:

1. On October 7, 2014, AEGS filed an application to increase its base rates pursuant to the less extensive filing requirements set forth in K.A.R. 82-1-231b, which applies to natural gas utilities which are not Class A utilities (defined as utilities whose gross annual income is less than \$1 million, K.A.R. 82-1-204a(a)). AEGS's gross annual income for the test year (12-month period ending December 31, 2013) was \$370,845.00. AEGS also requested approval of its new agreements with American Energies Pipeline, LLC ("AEPL"). On October 28, 2014, AEGS filed an Amended Application.

2. On October 7, 2014, CURB filed a petition to intervene.

3. On October 14, 2014, CURB's petition for intervention was granted.

4. The Parties have met and have agreed, subject to obtaining Commission approval, to the proposed procedural order ("Proposed Order"), and the provisions contained therein, which is attached to this Joint Motion as Exhibit A.

5. The Parties have previously submitted the proposed order to Mr. Van Blaricum, the

hearing officer assigned to this case, for his review and approval, and to confirm the availability of the hearing dates.

6. As part of this Joint Motion, AEGS has agreed to extend the 240-day statutory deadline for the Commission to issue a final order in this matter from June 1, 2015, to July 15, 2015.

WHEREFORE, the Parties move the Commission for an order approving the proposed procedural order which is attached hereto.

The above-captioned matter comes before the State Corporation Commission of the State of Kansas ("Commission") for consideration and decision. Having reviewed the files and records, the Commission makes the following findings and conclusions.

I. BACKGROUND INFORMATION

1. On October 2, 2014, American Energies Gas Service, LLC ("AEGS") initiated this proceeding by filing an Application to make changes to its charges for natural gas service pursuant to K.S.A. 66-117 and K.A.R. 82-1-231b. K.A.R. 82-1-231b applies to natural gas utilities which are not Class A utilities (defined as utilities whose gross annual income is less than \$1 million). AEGS's gross annual income for the test year (12-month period ending December 31, 2013) was \$370,845.00. AEGS also requested approval of its new agreements with American Energies Pipeline, LLC ("AEPL"). On October 28, 2014, AEGS filed an amended application. AEGS stated it is a natural gas public utility operating in the State of Kansas pursuant to certificates of convenience and necessity issued by the Commission. AEGS's principal place of business within Kansas is located at 136 N. Main Street, Canton, Kansas 67428. AEGS stated it provides natural gas service to 165 residential

customers, 48 commercial and irrigation customers in Harvey, McPherson and Marion Counties, Kansas and provides wholesale gas transportation service to the City of Hesston, Kansas.

2. On October 7, 2014, the Citizens' Utility Ratepayer Board ("CURB") filed a Petition to Intervene. On October 14, 2014, the Commission issued an Order granting CURB's intervention and issued a discovery order, protective order and order designating a prehearing officer.

3. On December 15, 2014, the Parties filed a Joint Motion proposing a procedural schedule setting deadlines under the procedures set forth in K.A.R. 82-1-231b.

II. PROCEDURAL SCHEDULE

4. The Commission finds the bifurcated procedural schedule following the procedures outlined in K.A.R. 82-1-231b recommended by the Parties to be reasonable. The Commission adopts the following bifurcated procedural schedule:
