ORDER DESIGNATING PREHEARING OFFICER AND SETTING PREHEARING CONFERENCE

)

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having examined its files and records, and being fully advised in the premises, the Commission finds the following:

1. On March 12, 2018, Cholla Production LLC (Cholla) filed an Application seeking

injection authority into the Marmaton C Formation at the Metzger #1-16 well.¹ On March 27, 2018,

Lario Oil & Gas Company (Lario) filed a letter of protest.²

2. On June 12, 2018, the Commission denied Cholla's motion to dismiss Lario and stayed

proceedings pending resolution of Commission Docket 17-CONS-3516-CUNI; at the time, the

Commission's decision in that docket was on appeal before the Scott County district court.³

3. On January 25, 2019, the Commission's decision to deny dismissal of Lario and stay proceedings in this docket was upheld on appeal before the Scott County district court; the decision was appealed no further.⁴

4. On August 23, 2019, Commission Docket 17-CONS-3516-CUNI was resolved through the Kansas Court of Appeals affirming the Commission's decision in that docket; no further appeal was made.⁵

5. In light of the above, the Commission finds that a Prehearing Officer should be designated in this proceeding to address any matters listed in K.S.A. 77-517(b),⁶ and that a Prehearing Conference should be scheduled.

THEREFORE, THE COMMISSION ORDERS:

C. <u>Commission Staff is directed to have an attorney file a written entry of appearance</u> on behalf of Staff prior to the Prehearing Conference, as Staff's previous attorney of record is no longer with the Commission.

D. At the Prehearing Conference, parties shall be prepared to discuss deadlines for filing testimony and briefs, discovery procedures, scheduling of a hearing with the Commission, and/or any other issues that will promote the orderly and prompt resolution of this proceeding.
