ORDER GRANTING MOTION AND CLOSING DOCKET

1. On July 19, 2013, Wheatland Electric Cooperative, Inc. ("Wheatland") filed its Application seeking Commission establishment and approval of adjustments to water rates for the City of Garden City, Kansas, Tyson Fresh Meats, Inc., Finney County Rural Water District No-1, and Sunflower Electric Power Corporation. Wheatland further requested that it be authorized to withdraw its application without prejudice.

2. On August 12, 2013, Wheatland filed its Motion to Withdraw Application.

3. The Commission finds and concludes Wheatland's Motion to Withdraw Application should be granted and this docket should be closed.

IT IS, THEREFORE, BY THE COMMISSION ORDERED THAT:

(A) The Application filed by Wheatland Electric Cooperative, Inc. is hereby withdrawn and this docket is hereby closed. Nothing in this order shall prohibit Wheatland Electric Cooperative from refiling its application, in accordance with Commission regulation, at a later date.

(B) The parties have fifteen (15) days, plus three (3) days if service of this order is by mail, from the date this order was served in which to petition the Commission for reconsideration of any issue or issues decided herein.¹

(C) The Commission retains jurisdiction over the subject matter and the parties for the purpose of entering such further orders as it may deem necessary and proper.
