**JOINT MOTION FOR PROCEDURAL ORDER**

Victory Electric Cooperative Association, Inc. (Victory), the Staff of the State Corporation Commission of the State of Kansas (Staff and Commission, respectively), and Kansas Electric Power Cooperative, Inc. (KEPCo), (collectively referred to as Joint Movants) hereby move the Commission for an Order establishing a procedural schedule in the above-captioned matter. In support of its motion, Joint Movants state the following:

1. On May 1, 2017, Victory filed its Application seeking approval to make changes to its Local Access Delivery Service (LADS) charge assessed to wholesale users of Victory's 34.5KV system.<sup>1</sup> The filing was made in accordance with the 34.5kV Formula Based Rate (34.5kV FBR) plan established and approved by the Commission in Docket No. 16-MKEE-023-TAR.<sup>2</sup>

2. The 34.5kV FBR plan, as approved, contains a timeline under which the annual 34.5kV filings will be filed and reviewed. Specifically, the timeline is set forth in the 34.5kV FBR plan Protocols, which is attached as Exhibit C of Attachment A to the Commission's Order approving the 34.5kV FBR plan.<sup>3</sup> For ease of reference, Joint Movants conferred in order to identify the specific dates for each action item identified in the 34.5kV plan timeline, based upon

the May 1, 2017 filing date and the general timeline approved as part of the 34.5kV FBR plan.

That proposed schedule, as agreed to by Joint Movants, is as follows:

Commission Order (either approving the rate adjustment based upon the paper record or notifying the parties that an evidentiary hearing will be held)	Thursday, September 28, 2017
Evidentiary hearing, if necessary	Tuesday October 10, 2017
Commission Order, if Evidentiary Hearing <sup>4</sup>	Thursday October 26, 2017
