
STATEMENT ADDING WELL TO COMPLIANCE AGREEMENT

On August 2, 2016, the Commission issued an Order Approving Compliance Agreement in this docket. The Agreement provides that if Staff discovers additional wells, not listed on Operator's well inventory, on leases where wells subject to the Agreement are currently located, then at its discretion, Staff may add the additional wells to the Agreement.¹

Staff recently discovered the Berlin #12, API #15-019-40765-00-01, a well not listed on Operator's well inventory, on a lease where wells subject to the Agreement are currently located. Operator has expressed a desire to plug the well and is not opposed to the addition of the well to the Agreement.

Staff hereby adds the Berlin #12 to the Agreement.






