responses. Moreover, both parties will need to prepare more generally for the anticipated hearing.

6. Due to the above reasons, Staff and Operator submit this motion jointly and request

the Commission grant an extension on the hearing in this docket, currently set for September 19,

2019.

WHEREFORE, Staff and Operator respectfully submit that the hearing in this matter be

continued approximately 60 days, until November 20, 2019, and for such further relief as the

Commission deems just and reasonable.
