MOTION TO AMEND PENALTY ORDER

The Staff of the State Corporation Commission of the State of Kansas (Staff and Commission, respectively), by and through its counsel Ahsan A. Latif, file this Motion requesting the Commission issue an Amended Penalty Order reducing the penalty assessed to Unruh Transport Inc. (Unruh Transport), by fifty-percent (50%) less than the penalty assessed in the Penalty Order dated April 20, 2017. In support of this Motion, Staff states as follows:

1. On April 20, 2017, a Penalty Order was issued to Unruh Transport assessing it a penalty of \$1,000 for one (1) violation(s) of Kansas law that governs motor carriers, including various provisions of the Federal Motor Carrier Safety Regulations (FMCSRs), as adopted by the Kansas Administrative Regulations. The violations were found during a Safety Compliance Review conducted by Special Investigator(s) Doug Handy, on March 7, 2017.

2. The Notice of Penalty Assessment attached to the Penalty Order advised Unruh Transport it was a New Entrant carrier and was eligible for a fifty-percent (50%) reduced penalty if it submitted a signed and dated Reduced Penalty Agreement within fifteen (15) days from the date of the Penalty Order, stating it will comply with the reduced penalty option terms and obligations stated therein.

3. On April 29, 2017, Unruh Transport submitted the Reduced Penalty Agreement. The Corrective Action Plan was submitted by the carrier and has been approved by

Transportation Staff. The Reduced Penalty Agreement is attached hereto and is hereby incorporated by reference.

4. Staff recommends the Commission issue an Amended Penalty Order assessing Unruh Transport a reduced penalty of \$500 (50% less than originally assessed) and requesting it to comply with the following terms and obligations:

- a. within thirty (30) days from the date of the Penalty Order dated April 20, 2017
Unruh Transport shall send an individual responsible for safety compliance to attend a Commission-sponsored safety seminar, and proof of attendance must be submitted to the Transportation Division;
- b. within eighteen (18) months of the Penalty Order dated April 20, 2017, Unruh Transport must submit to a follow-up Safety Compliance Review.
Transportation Staff will contact the carrier to set up the review; and
- c. within (30) days from the date of service of the Amended Penalty Order
Unruh Transport must submit payment of \$500.

WHEREFORE, for the reasons set forth herein, Staff requests an Amended Penalty Order be issued by the Commission assessing Unruh Transport Inc. a reduced penalty of \$500, which is fifty-percent (50%) less than penalty(s) assessed pursuant to the FY 2017 Uniform Penalty Assessment Matrix, and ordering it to comply with the proposed terms and obligations set out in paragraph 3 above.

REDUCED PENALTY AGREEMENT

17-TRAM-458-PEN

Unruh Transport Inc. hereby submits this Reduced Penalty Agreement to become eligible for a fifty percent (50%) reduction in the penalty assessed in the Penalty Order dated April 20, 2017. Unruh Transport has agreed to comply with the following terms and obligations:

1. Unruh Transport has submitted, within fifteen (15) days from the date of the Penalty Order issued on April 20, 2017, this Reduced Penalty Agreement to Litigation Counsel at the above address.

2. Unruh Transport will, within 30 days from the date of the Penalty Order dated April 20, 2017, submit to Transportation Staff an approved Corrective Action Plan (CAP) documenting the violation(s) describing specific and detailed information explaining the carrier's efforts and concrete steps taken to ensure the violation(s) do not occur in the future.

3. Unruh Transport will, within thirty (30) days from the date of the Penalty Order dated April 20, 2017, send an individual responsible for safety compliance to attend a Commission-sponsored safety seminar, and proof of attendance will be submitted to the Transportation Division.

4. Unruh Transport will be available within eighteen (18) months from the date of the Penalty Order for a Safety Compliance Review. Transportation Staff will contact it to schedule the review.

Unruh Transport Inc. understands that if approved, Transportation Litigation Counsel will file a Motion for Amended Penalty Order with the Agreement attached to the motion. The Amended Penalty Order will assess Unruh Transport a fifty-percent (50%) reduced penalty of \$500, and set out the terms of the agreement above. Once the Amended Penalty Order is issued by the Commission, Unruh Transport will have thirty (30) days from the date of service of the Amended Order to pay the reduced penalty.


