ORDER GRANTING MOTION TO RESCHEDULE

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having reviewed its files and records, and being fully advised in the premises, the Commission makes the following findings:

1. On November 8, 2018, the Commission issued an *Order Granting Hearing* in this Docket, setting a hearing for January 8, 2019, at 10:00 a.m., in the First Floor Hearing Room at the Commission's Topeka Office.

2. On November 16, 2018, Commission Telecommunications Staff (Staff) filed an Unopposed Motion to Reschedule Hearing to January 9, 2019, stating that a scheduling conflict rendered Staff unavailable on January 8, 2019.¹ No party objected to Staff's Motion.²

3. Based on the above, the Commission finds the hearing currently scheduled for January 8, 2019 **shall be rescheduled for Wednesday, January 9, 2019, beginning at 9:00 a.m.,** First Floor Hearing Room, 1500 SW Arrowhead Rd., Topeka, Kansas.

B. The hearing shall be held on January 9, 2019, at 9:00 a.m., in the First Floor Hearing Room at the Commission's Topeka Office.


B. Any party may file and serve a petition for reconsideration pursuant to the requirements and time limits established by K.S.A. 77-529(a)(1).³
