3. Pursuant to the above mentioned Commission Orders, the Commission has the authority to require an evidentiary hearing on the matter of setting just and reasonable rates concerning So. Pioneer’s DSC Plan. The Commission will preside. Any party who fails to attend or participate in the hearing (if necessary) or any other stage of the proceedings may be held in default.<sup>1</sup>

4. The Commission notes and accepts So. Pioneer’s waiver of the 90 day deadline for approval sans hearing in the event So. Pioneer’s companion docket *Annual Filing of Southern Pioneer Electric Company to its Charges for Electric Services, Pursuant to the 34.5 kV Formula Based Rate Plan Approved in Docket No. 16-MKEE-023-TAR*, Docket No. 16-SPEE-501-TAR (May 4, 2016) necessitates a hearing.
